- €750.00 / frozen straw.
- Vet fees, mare boarding fees, and frozen semen shipment costs will be charged to the mare owner
- Orders for frozen semen are to be made exclusively via Zuuthoeve Stud Farm
- Payments shall be paid after receipt of our invoice and before delivery of the ordered straws, when Zuuthoeve this payment received, your order has passed and shipped.
- No discounts shall be offered
- No guarantees can be given on frozen semen
- Purchased semen straws become the sole property of the mare owner and may not be resold;
   service certificates are issued solely in the name of the mare owner, according to the order form of the purchased semen straws
- Should the owner wish his mare to undergo embryo flushing, he must inform Zuuthoeve Stud Farm when placing the first order
- The mare owner must provide Zuuthoeve Stud Farm, before 01/10/23, with an overview of the number of successfully implanted embryos per mare, issued and signed by the vet or embryo transfer centre. As from the second embryo, a supplement of €100.00 excl. 21% VAT will be charged for administration costs per service certificate issued
- Once the mare becomes pregnant, the mare owner will receive a service certificate stating the
  date of the last insemination. This document is required for the notification and registration of
  the foal after birth. The service certificate will only be issued upon receipt by Zuuthoeve Stud
